### **Qualification definitions for Retrievers as per J7i (1)**

Preference in the draw will be given to dogs which have gained awards as follows.

**Open:** 1<sup>st</sup> 2<sup>nd</sup> 3<sup>rd</sup> or 4<sup>th</sup> in a 24 dog Open Stake, 1<sup>st</sup> 2<sup>nd</sup> or 3<sup>rd</sup> in a 12 dog Open Stake, or 1<sup>st</sup> in All Aged or Novice Stakes.

**Novice:** Dogs which have NOT gained a 1<sup>st</sup> 2<sup>nd</sup> 3<sup>rd</sup> or 4<sup>th</sup> in a 24 dog Open Stake,

1<sup>st</sup> 2<sup>nd</sup> or 3<sup>rd</sup> in a 12 dog Open Stake or 1<sup>st</sup> in All-Aged or Novice Stakes.

**All Aged:** Preference in the draw will be given to dogs with ANY Field Trial Award, including COM.

All our Trials are held under Kennel Club Ltd. Rules and Field Trial Regulations.

Should circumstances so dictate, the Club, in consultation with the Judges, may alter arrangements as necessary.

Such changes and the circumstances surrounding them must be reported to the KC at the earliest opportunity.

Substitution of dogs will be allowed subject to qualification as above.
